**RULES FOR PARTICIPATION IN THE TRADE-IN PROGRAM
(the "Rules")**

Effective from 10:00 AM (Bishkek time)

1. General Provisions

1.1. A participant of the TRADE-IN Program (the "Program") (an individual aged 18 and above, registered in the IQOS and lil System User Database, the "Participant") is offered an opportunity to buy an IQOS ORIGINALS DUO or lil SOLID Electric Heated Tobacco System (the "New Device") at a special price indicated in Appendix 2 hereto, upon transfer of the previously used IQOS or lil Electric Heated Tobacco System in accordance herewith.

1.2. The Program shall apply to the official IQOS stores (the "IQOS Stores") and personal sales assistants until 31.12.2023

1.3. To participate in the Program, the Participant shall visit an IQOS Store or contact a personal sales assistant and state his/her willingness to take part in the Program.

1.4. Under the terms and conditions of the Program, the used IQOS Electric Heated Tobacco Systems (models 2.4 and 2.4P, including limited versions, models 3, 3 Multi, 3 DUO, ORIGINALS DUO), as well as lil Electric Heated Tobacco Systems produced for other markets (i.e. not intended for the official sale in the Kyrgyz market and not registered in the official Company's Database), as well as used electric heated tobacco systems (IQOS 3 DUO, IQOS ORIGINALS DUO or lil SOLID 2.0) previously purchased from the Company in the Kyrgyz market, registered in the official Company's Database, with one (1) month or less left before the expiration of the warranty period, (the "Used Devices") shall be accepted from the Participants.

1.5. The Program may include Used IQOS/lil Devices, including non-operational devices. The original box is not necessary. The IQOS Heated Tobacco System shall include at least a charger and a holder.

1.6. In the events where the Participant visits an IQOS Store or contacts a personal sales assistant, the Used Device shall be transferred by the Participant to the Company on a non-returnable basis under the Acceptance and Transfer Certificate.

1.7. When the Participant transfers the Used Device, he/she shall have an option of buying a New Device at a price as indicated in Appendix 2 hereto.

1.8. The New Device being bought under the Program, shall be returned and exchanged in accordance with the legislation of the Kyrgyz Republic. The warranty shall cover the devices bought under the Program as well as the devices bought not under the Program. No refund shall be provided for the Used Device in case of returning or exchanging the New Device.

1.9. The New Device being bought may be paid for with cash or a bank payment card. Gift cards are not accepted.

2. Restrictions

2.1. Availability of the New Device in all colors shall not be guaranteed at the time of its purchase.

PLEASE NOTE: The special TRADE-IN price is not valid either with any other special prices when buying in the IQOS Stores or from the personal sales assistants, or with a special price available upon application of a referral code or voucher received under the Referral Program.

3. Final provisions

3.1. The Rules of the Program may be amended and/or supplemented through making the updated Rules available in the IQOS Stores and their posting at www.iqos.com. The updated Rules of the Program shall become effective as of such posting. By continuing to apply the Vouchers upon amendments and/or supplements made to the Rules of the Program, the Participant confirms his/her consent to the updated Rules of the Program.

3.2. The Program may be cancelled without further notice or explanation of the reasons.

3.3. The Participant agrees to the Rules of the Program at the time of transfer of the Used Device in the IQOS Stores / to the personal sales assistant in accordance with Section 1 hereof.
